APPLICATIONS

Will be accepted from 1st October CHARGES Pavilion \$220 [3M x 3M incl minimal power & GST]

Outside Unpowered sites \$220 3M x 3M [minimum charge] 6M frontage to main access roadway- \$275 5-7M frontage along rear access road- \$220 The above charges include minimal power eg. Light and computer.

ELECTRICITY

Where additional power [esp.3 phase] &/or water is required there will be a service charge of \$55 per site connection. The Society cannot guarantee more than one power point for each stand and usage of electricity must be limited.

PAYMENT

On receipt of a completed application form a Tax Invoice will be issued. Full payment is required before 15th January or space may be reallocated.

Electrical Tagging

Any exhibitors intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow Exhibitors and the general public and is a requirement of the Workplace Health & Safety Act which imposes severe penalties for non compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Showground. PLEASE CHECK ALL YOUR ELECTRICAL EQUIPMENT AND LEADS BEFORE YOU COME TO THE SHOWGROUND TO AVOID ANY PROBLEMS.

GATE PASSES

Every person entering the Showground must have a pass. Each stand will be issued with two free passes ONLY. All other passes must be paid for. Passes will be in the form of wristbands or cards to be collected on arrival from the office.

<u>Commercial passes</u> will not be issued to children. A limit on the number of commercial passes for each stand may be imposed by the society. SEE OVER FOR FURTHER DETAILS

VEHICLE ACCESS

Vehicles to service stands must access the ground by Park Lane gate. ALL VEHICLES MUST LEAVE THE GROUND PRIOR TO 9 a.m. each day of the Show.

ERECTION OF STANDS

No work on stands or displays in the Pavilion Friday morning when rural exhibits are being judged. These stands may be erected on Thursday or after 1 p.m. on Friday.

DISMANTLING OF STANDS: Agricultural exhibits will not be removed until Monday following the show. Commercial exhibits in the Pavilion may be removed after 6.30 p.m. on Sunday with the approval of the Chief Pavilion Steward. All outside stands must remain for the duration of the Show.

INSURANCE

All exhibitors are advised that it is a requirement of Trustees Bega Showground that all trade exhibitors must have public liability insurance for a minimum of \$20m. Please forward a photocopy of your policy with your application. You should also check with your insurance company for cover for workers' compensation, goods insurance and any other necessary cover while you are at the Show.
